BOARD OF DIRECTORS MEETING MINUTES October 10, 2007

1) OFFICERS

Minutes of 9/26/2007 taken by Sandee Blalock. Motion to accept minutes by Ray, second by Gail. All approved.

Guest: Mike Galligan, SFI Insurance

Our policy for general liability includes directors/officers. It does not include property. Minimum premium to insure property is \$150, covers up to \$25,000 damages to fences and equipment and plants/trees up to \$500 per plant. Deductible is \$500. We must name the fence in the policy as being insured. Bryan made a motion to add the outdoor policy for \$150 / year up to \$25,000 in coverage to the policy. Seconded by Gail. All voted in favor.

4. Committee Reports

1) Construction: Ray reported that we will no longer need the porta-potty (although we will keep it for the Pumpkin Party). Bryan asked about the status of Whitson permits. Wetlands plan needs to be done. 2) Pumpkin Party: Nancy reported that everything is ready for the Pumpkin Party. Virginia said that t-shirts will be given to the 1-3rd place winners. Discussed having a perpetual trophy listing the winners each year. Andy to give Virginia information on funds needed for the next phases of work. Sandee to call her contact at KRCR news. Sandee to get in touch with Jean Littleton regarding the Saturday work day. 3) Grants: Bryan went to the McConnell Foundation and learned that the deadline for local grants was in September. We can apply again in March. Bryan will check back in February. Betty Paris is getting proposals to Waste Management and Meek's. Glenda will contact Doug LaMalfa's office to find out if any state money is available for community parks. Eddie to call Keli Anthis at Shasta College. Bryan will complete the county refund but needs invoices to get this done. He will finish within the next month.

- 6) In House Marketing proposal: Discussed the proposal and all the components. Bryan asked for up to \$5,000 for the first phase. Andy likes the Powerpoint update. Gail recommended doing one part and

- seeing how the costs work out. Ray made a motion to move forward with the items in the proposal up to \$3,800 for the first phase. Bryan seconded the motion. All voted in favor. Bryan to follow up.
- 7) Bricks: At the last meeting, Ray presented a drawing on how we could use the bricks within the gate/entry of the park. Emilie made a motion to go with Ray's design. Nancy seconded the motion. All voted in favor. Bryan will take the design to the Builders' Exchange.
